Applicant Commitment

As a 2025–2026 Public Health Management Certificate (PHMC) program applicant, I understand that the program involves a 12-month commitment. I am willing and able to make the following commitments if invited to be a scholar in the program:

- 1. To devote the time necessary to fully participate in the program's activities, including:
 - Attendance at an orientation webinar held June 25, 2025, 10 a.m. to 11 a.m. Pacific.
 - Attendance at an in-person session held August 18 August 21, 2025, in Seattle, WA.
 - Participation in weekly webinars held Wednesdays at 10 a.m. Pacific starting in September 2025 and ending in June 2026.
 - Dedication of approximately 6–8 hours a week on coursework, such as webinars, readings, homework assignments, and distance-based small or large group sessions.
 - Creation of a project that is integrated with my workplace. I will begin the project at the in-person session and conclude it
 with a written report and online presentation in June and July 2026.
 - Identification of a personal development goal and progress towards it throughout the program term.
- 2. To be an active contributor during the program sessions and an active team member on small group learning teams.
- 3. To have regular access to a computer with Internet access to participate actively in scheduled programs or sessions conducted using distance education technologies.
